Update from Farm Animals Department

It has been a difficult few years for the poultry sector, and we are aware of the challenges this brings to the farming community.

The RSPCA will be publishing updated laying hen welfare standards and turkey welfare standards towards the end of this year. We will continue our work to ensure the welfare standards provide animals with the best possible environment to give them a good life. Key areas of focus will be managing feather cover, preparing for avian influenza and progressing housing standards.

The RSPCA Farm Animals Department, which sets the higher welfare standards for farms to be certified as part of the RSPCA Assured scheme, is asking RSPCA Assured members to share their experience with managing feather pecking and keeping intact beak birds.
