

# Suppliers' chain of custody requirements

To sell/promote products as RSPCA Assured you must:

### Be a member

If you or your customer want to sell a product to another business\* using our registered RSPCA Assured name and certification mark **you must be a member and have your own certificate (your supplier's certificate is not sufficient).** 

**Every member is audited**. This means we can monitor traceability throughout the supply chain – protecting you, your supplier, your customer, and ourselves.

#### 2 Keep accurate records

Your auditor will expect to see detailed records and processes for the following:

- What you are sourcing
- Who you are sourcing it from
- How you are segregating the product
- What you are doing with the product
- Where your product is going
- How much you are sourcing from each supplier
- How much you are supplying to each customer

### **3** Use assured suppliers

If you want to market and sell a product or ingredient as RSPCA Assured you must:

- Source that product or ingredient from assured suppliers every supplier in the chain must be a member, including off-site/third party units such as freezing/cold storage etc.
- Have a fully traceable supply chain from farm to fork – members must fill in an online traceability proforma when requested and inform us of any changes.
- If purchasing from an abattoir check it is assured – not just the farm. If these key parts of the chain are not assured then the product cannot be sold as RSPCA Assured.
- Ask to see a certificate and be sure it is valid by checking the date. If in doubt, contact us with their eight digit membership number or the first line of their address and postcode.

### **4** Use the certification mark correctly

To use the certification mark you must:

- Be an assured member
- Use assured suppliers
- Adhere to our logo and brand guidelines
- Submit artwork to artwork@RSPCAassured.org.uk for approval prior to print and publication

The name RSPCA Assured<sup>®</sup> is registered and cannot be used without the logo; the logo cannot be used on websites and other marketing communications to promote products or dishes that are not RSPCA Assured.

## **5** Pay the levy (licence fee)

- Members must submit a completed Levy Return Form within 14 days of quarter end.
- A levy is due on all RSPCA Assured products and is payable by all members unless advised otherwise.
